Introduction



The FSAI has played an important leadership role in strengthening Ireland's food control system over the last 25 years since it was established in 1999. This new Strategy has

been developed to continue this leadership role to safeguard public health and to foster trust in Ireland's food systems. This will ensure that the food reaching consumers in Ireland and consumers of Irish food abroad is safe, authentic, and produced to the highest standards in line with our legal mandate under the FSAI Act, 1998.

This 5-year Strategy and the supporting implementation plan for the first 3-years sets out how we will deliver on our legal mandate and prepare for the challenges and opportunities ahead.

This Strategy builds on the significant achievements of the previous Strategy that guided the FSAI in an evolving policy, legislative and risk environment. As the central competent authority, the FSAI has led and supported the continuous improvement of Ireland's food control system to address the changes associated with Brexit, the introduction of a significant change in the EU legislation for how we carry out food controls, managed several large food incidents, investigations and protected disclosures to address significant risks, and worked with official agencies to support an effective official control system as they have undergone changes in their delivery models. The FSAI also intensified its efforts in strengthening our European and international relationships through our commitment to the European Food Safety Authority, the European Heads of Food Safety Agencies and the International Heads of Food Agencies Forum.

We have carried this out by working with our team and our partners in Government, State agencies, and our international partners, and with the industry, while navigating a myriad of challenges including the COVID-19 pandemic, ongoing geopolitical situations that continue to create challenges to the safety of our food system, as well as growth in Ireland's food industry – an industry that continuously embraces new technologies and innovation across complex supply chains but that is also navigating challenges that have the potential to impact on food safety and authenticity. A strong and effective national regulatory system is critical to underpinning a safe and sustainable food industry.

As we look to the next 5 years, we will need to be cognisant of the external policy environment - nationally and internationally. We will need to understand the dynamics of a rapidly evolving food landscape where global supply chains, emerging technologies, the impacts of climate change, the transition to more sustainable food systems, and shifting consumer expectations and preferences, all of which will create both opportunities and challenges. Within this complex landscape we will continue to protect consumers here in Ireland and consumers of Irish food in more than 180 markets across the world in partnership with the Government Departments and State agencies in Ireland and through our engagement with our European and international counterparts.

The FSAI has recently undergone a Periodic Critical Review process with the Department of Health, and we look forward to working with the Department to implement improvement opportunities that arise from this. We are also looking to the organisation and system opportunities provided by the transfer of the Local Authority Veterinary Service to the Department of Agriculture, Food and the Marine from 2025 which will result in a

significant change to some aspects of the FSAI operations as well in the food control system that the FSAI oversees.

Our vision of "safe and trustworthy food for everyone" remains our guiding principle, continuing from our last two strategies. Extensive stakeholder consultation has reaffirmed this vision, ensuring it remains relevant and central to our objectives. In this Strategy, we clearly articulate our purpose as a public sector body, supported by four strategic goals that position us to effectively navigate future challenges and opportunities.

As Ireland's independent, statutory food safety regulator and the central competent authority for food safety, we will uphold our duty to protect public health and consumer interests by:


- Building a culture of food safety
- Improving food safety within a risk analysis framework

- Continuing to drive organisational excellence.

This Strategy outlines the FSAI's commitment to our leadership utilising a proactive, evidence-led regulatory approach that will strengthen Ireland's food safety practices while promoting transparency, accountability, and collaboration across the entire food chain. With clear 5-year goals and objectives, and a set of high-level deliverables to be achieved within the first 3-years of the Strategy, the FSAI is positioning itself to respond effectively to new risks and challenges. This new Strategy will build on our strong foundations, embracing new ways of working; leveraging modern tools and technologies to drive greater efficiencies; utilising data to inform faster and more effective decisions and gain insights; advancing organisational excellence through developing our people and our systems to meet the challenges and opportunities that will

undoubtedly arise in the future. Our strategic goals are focused on:

- Advocating for the importance of food safety and authenticity in our engagement with all stakeholders to better protect consumers' health and interests and increase compliance
- Enhancing our ability to protect consumers' health and interests by anticipating, assessing, and managing risks that impact on the safety and authenticity of food
- Ensuring and verifying compliance with food law, taking appropriate enforcement action, to protect consumers within a coherent national regulatory framework
- Delivering better food safety outcomes for consumers through empowering our people, aligning our systems, and demonstrating adaptive, values-driven leadership.

As stated above, we have set out our 5-year goals and objectives that will guide our activities supported by a number of high-level deliverables that we will achieve in the first 3-years of the Strategy. We will report annually on our progress against these deliverables. We also commit to reviewing this Strategy at its mid-point, to ensure we stay responsive to the external environment and we will adapt our approach accordingly. We look forward to collaborating with our Board, colleagues in the Departments of Health and Agriculture, Food and the Marine, our regulatory partners, laboratories, and other State agencies in Ireland and across the island. Together, we will continue to protect consumer health and interests.

About Us

Who we are

The Food Safety Authority of Ireland (FSAI) was established under the Food Safety Authority of Ireland Act, 1998 as an independent government agency responsible for the enforcement of food legislation in Ireland. This Act was enacted in July 1998 and came into effect on 1 January 1999.

The FSAI is a statutory, independent and science-based regulatory enforcement body dedicated to protecting public health and consumer interests in the areas of food safety, hygiene, integrity and authenticity. It reports to the Minister for Health, who appoints a 10-member Board. The FSAI also has a 15-member Scientific Committee (also appointed by the Minister for Health) which assists and advises the Board. As a result. decisions relating to food safety, hygiene and integrity are made using the latest and best scientific advice, evidence and information available. This ensures that people in Ireland, as well as consumers of Irish food in 180 countries across the world, have access to safe and trustworthy food.

The FSAI is legally mandated to take all reasonable steps in order to make sure that food consumed, produced, distributed or marketed in Ireland meets the highest standards of food safety and hygiene reasonably attainable, and that food complies with legal requirements or, where appropriate, with recognised codes of good practice. These activities are key to underpinning Ireland's societal health and economic growth.

What we do

The FSAI's key remit is the enforcement of food legislation, which is coordinated through working in partnership with other food regulatory authorities.

Food legislation is enforced on behalf of the FSAI by a network of official agencies through a system of service contracts, which the FSAI monitors. The FSAI also reports on the official agencies' activities and seeks continuous improvement and accountability through a programme of regular audits.

The FSAI has a statutory obligation to foster the highest standards of food safety and hygiene in the food industry in Ireland. One of the ways it does this is through working closely with our stakeholders in the food industry fora in order to raise compliance.

The FSAI manages risks in the food chain and responds effectively to any national or international food incident or crisis, including through the European Commission's Rapid Alert System for Food and Feed. The FSAI aims to ensure the safety, integrity and authenticity of the food chain by detecting, deterring and preventing breaches of food law and taking action to protect consumers.

The FSAI has a statutory role of providing advice to Government to support risk-based decision-making and policy development with high-quality, independent scientific and technical expertise.

- ► Food incidents, protected disclosures and investigations of non-compliance with food law managed efficiently and effectively to protect consumers.
- Coordinated and consistent management of food incidents through cross agency engagement and agreement.
- Food safety risks communicated effectively to consumers to enable informed choices.

Objective

Continue to strengthen Ireland's capability and capacity to proactively identify, assess, manage, and communicate risks

- The FSAI is an active partner of the European Food Safety Authority contributing to the advancement of European risk assessment and risk communication.
- Ireland's ability to manage risk is strengthened through simulation activities, crisis preparedness and cooperation initiatives with national, European and international partners.
- Emerging risks and threats to and from the food system are identified and managed through improved systems and collaboration.

Augment risk-based decisionmaking and policy development through independent expertise

- ▶ The ongoing effectiveness of official controls is verified and demonstrated through independent audits of the official agencies, data analysis and other appropriate tools.
- Service contract arrangements are reviewed to identify areas for improvements.

Strengthen the national regulatory framework for food safety and authenticity to deliver the best outcomes for consumers. as part of an effective European food control system
